
# Welcome to the Omni

# QUALITY INTENSIVE: FALLING INTO BETTER SLEEP - HOW A FALL PREVENTION PROGRAM LED TO RESTORATIVE SLEEP



Sunday, August 24, 1 - 5 p.m.

A resident fall in a skilled nursing facility costs, on average, \$9,100 to \$13,500, according to the Centers for Disease Control and Prevention. In 2008, Empira, a Minnesota consortium of older adult service providers, received funding from the Minnesota Department of Human Services' Performance Incentive Payment Program to prevent and reduce resident falls in 16 of their SNFs. At the completion of their 3-year program, the facilities collectively achieved considerable reduction in resident falls, including a major decrease in the number of recurrent falls and falls with injuries. A root cause analysis conducted in the Empira Fall Prevention program showed that sleep deprivation and sleep fragmentation were the primary internal conditions that contributed to residents who fell. This in-depth session will show how these facilities are now alarm-free and restraint-free without low beds, floor mats, or gripper socks, and will highlight the best practices taken by facilities with their new 3-year grant, The Restorative Sleep Vitality Program. Presenter Sue Ann Guildermann, RN, Empira's director of education, produces educational seminars and conferences for Empira while also teaching at the University of Minnesota School of Public Health. She is a nationally recognized speaker and educator on healthcare topics (4 hours NAB/NCERS credit).


